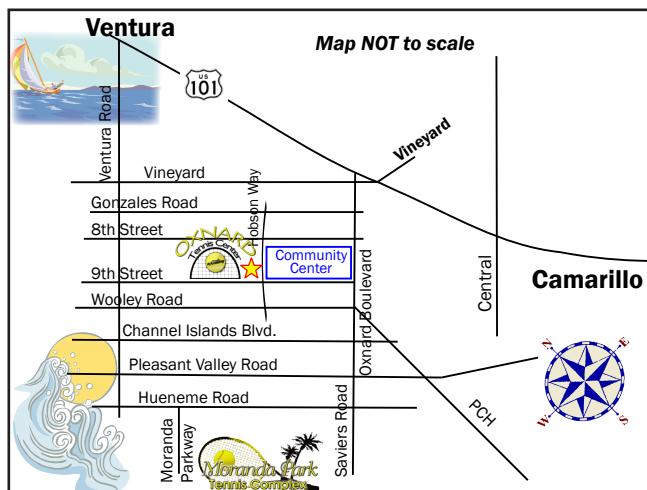

- Current USTA/NTRP ratings will be used to enforce proper levels of play. Players may play above their USTA/NTRP ratings. Players with no USTA/NTRP rating may still play the tournament using the NTRP self-rating system.
- Matches will be best of three tie-break sets using regular scoring.
- Players will be subject to default 15 minutes after scheduled match time.
- Divisions with three or less entries will be combined with other divisions.
- All results will go towards Southern California Tennis Association's 2009 NTRP rankings!
